**The TPP11 is heading to the finish line** as countries launch final talks in Vietnam this week on a few key provisions to fully revive the deal without the U.S. Yet Canada is dragging its feet on the deal. Canada has a choice in Asia: catch up, or get left further behind on trade. Earlier this year, we partnered with the Asia Pacific Foundation of Canada and brought together a group of industry, trade experts and media to talk about trade priorities. The TPP emerged as key to Canada's ambitions for market diversification and growth. 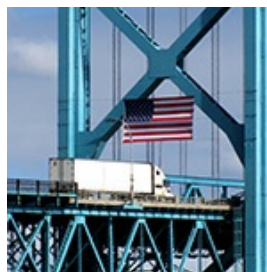

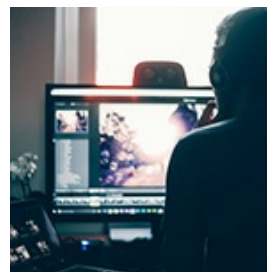

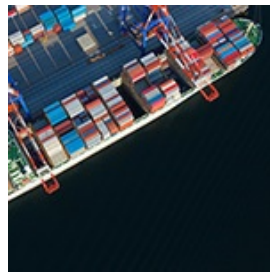
